Waste Transporters - NYS Dept. of Environmental Conservation

The Waste Transportation Safety (Act 90 of 2002, Chapter 62) requires all waste transportation vehicles (trucks and truck tractors with a registered gross vehicle weight greater than 17,000 lbs., and trailers with a registered gross vehicle weight greater than 10,000 lbs.) transporting municipal or residual waste to waste processing or disposal facilities in Pennsylvania to have a valid Waste Transporter Authorization. The law prohibits processing and disposal facilities from accepting waste ...
